#### This motion should be approved because (one or more motivations):

- Few delegates were present during SICOGA 2022 (30 out of 77). Only 22 absent delegates voted online. Developing virtual participation requires the use of user-friendly tools accessible to all.
- The use of a working tool such as Google groups would be more adequate than Teams which required much training to be accessible to all.
- During SICOGA itself, very little time was devoted to a serious analysis and debate on the

motions.

- Some time must be allocated, during the conference, for presenting and clarifying every important motion and the state of discussion for each of them:
  - o Either from EXCO's initiative, with workshops in groups to be more

efficient o Or from at least one delegate's demand

- Some accessible communication tools should be found to enable on-line participants to ask questions and make comments during discussions.
- At the same time, it could be a way of sharing tools within the Servas groups, tools
  dedicated to online meetings, exchanges and debates, throughout the year, outside
  the time of the motions.
- The use of Google cloud speech-to-text could facilitate understanding and participation in discussions
