4. Exact wording of the proposal to be voted on.

We propose that the May 2024 distant vote approves that:

- Spanish language be more used in debates, with direct transcription of what is said on a screen
- Enough time be devoted to clarification, discussion and debate of motions to be voted on.

- Rules of Order be edited to take into consideration the difficulty of non-English speaking delegates by giving them 4 minutes instead of only 2 to express themselves during SIGA

- Native English speakers take into consideration non-native English speakers and use simple English, slowly and distinctly so that everybody understands them. That the moderators are empowered to remind them of this as needed.

- A transcription on screen of what is said in English could be of great help. There is software that does it automatically.

Please note that SI member groups must be able to vote YES, NO or ABSTAIN on a SIGA proposal.

This motion should be approved because (one or more motivations):

• At SICOGA 2022, many non-English speaking delegates were not in a position to understand clearly the written documents nor oral exchanges, and had much difficulty expressing their ideas in a way to be understood by all.

• As an international association that values the diversity and richness of its member groups, limiting language obstacles is an essential condition to the quality of debates.

• The richness/quality of ideas arises from the cultural differences carried by languages

• The issue of languages is not new to Servas. Already in the decisions taken at the 2015 General Assembly (Totara Springs, Matamata, New Zealand), we find the following resolution: "It is agreed to include Spanish as a language used in communication in Servas International, with a budget of 10000 CHF for the first year, to be reviewed, and to appoint a coordinator."

• Giving access to all the necessary documents in Spanish several months before SICOGA would help delegates to study them with their Board members in advance, and to share ideas more actively in the SWGs.

• Systematizing the translation into another language during SICOGA is a way to make sure that the participants keep in mind the linguistic diversity, and take it into account in the discussions.

7. SI budget implications

Two **Servas** translators need to be appointed. Their transport and registration costs would be paid by SI: about 1500 CHF.

This would leave 8500 CHF out of the 10000 CHF budget to pay for software, technical tools...
