CRC must make every effort to help resolve an issue but in case there is no final agreement, CRC has the final authority while respecting Servas principles and rules; this decision must be binding and officially adopted by the sides involved.	Proposed new wording: Servas Canada proposed a new wording to merge this motion to combine both the CAN 002 motion with the ARG - URG 004: Title Servas officers are obligated to work with the Servas International Conflict Resolution Committee (SI CRC) when there is a formal complaint. Motion Summary When SI CRC is asked to mediate in a conflict, Servas officers must comply with the decisions reached through mediation. Failure to comply may mean that an officer may be removed from their position according to the seriousness of the complaint and the lack of a timely response from the officer. The SI CRC will continue to support neutral mediation and positive collaboration. This new wording didn't get a global approval yet.
