**6. SIGA 2025 should approve this motion because (one or more motivations):

- .... A Development Plan or Roadmap is an essential management tool setting out the strategies and goals that need to be followed to achieve Servas' mission and vision. It should inform efficient planning and allocation of resources so activities are aligned with strategic goals; and enable risks to be identified and mitigated;
- ... The Plan will increase credibility and trust as Member Groups and other stakeholders will have been consulted prior to its adoption;
- ... Having a Development Plan differs from current practice in that it will establish a holistic framework for Servas' activities, and should help in prioritising goals.
- ...Implementation could be by SI Exco establishing an ad-hoc Task Group to produce an initial draft; that draft then becoming the subject of wide consultation with Member Groups and SI Entities. Following the consultation period SI Exco would arrange for the final draft to be presented for adoption by means of a virtual SIGA or Distance Vote in, say, 12-15 months. Following adoption, the Plan, which should be on a rolling basis would be monitored, reviewed and updated regularly in consultation with Member Groups and other stakeholders.
- ...Each strategic goal would be SMART (Specific, Measurable, Attainable, Responsible, and Time-Bound). Having SMART goals, for example 30,000 members by 2030 or x % of members under 30 by 20xx, will allow progress to be tracked, and any necessary adjustments made. It will improve accountability and transparency.
