**There will be 2 motions to be decided by DV Nov 2021:**

**Motion 1 – EXCO – 01 – Nov2021 To approve the 2020-2021 Audited Accounts To approve the April 1 2020 – March 31 2021 audited accounts (Financial statements, External audit report, Internal audit report, and EXCO response to the internal audit report attached).**

**Motion 2 – EXCO – 02 – Nov 2021 To appoint Auditors for 2022 To re-appoint SEN AND RAY, Chartered Accountants, as external auditors for fiscal year 2021-22. (SEN AND RAY has provided us with a letter that they are eligible and willing to be our auditors for the next year.)**

A general announcement of the motions in DV Nov 2021 was sent to all Servas countries, to **country@servas.org** e-mail addresses. You may also receive this, if they are forwarded to you. The timetable for the key Voter steps in the process for DV Nov 2021 is:

Now to Nov 30, 2021	Member Groups, who are eligible to vote, will determine how their vote will be cast on the DV motion.
September 2021	Checking the Voter List for DV Nov 2021.
By Oct 31, 2021	DVA sends out of Voting Papers and voting instructions to Voters.
By Nov 30, 2021	Voters return voting papers to DVA.
<b>Nov 30, 2021</b>	<b>Voting Closes/Ends</b>
By Dec 31, 2021	DVA counts votes and reports results to SI GenSec. SI GenSec advises NatSec and EXCO of Distant Vote Results.
